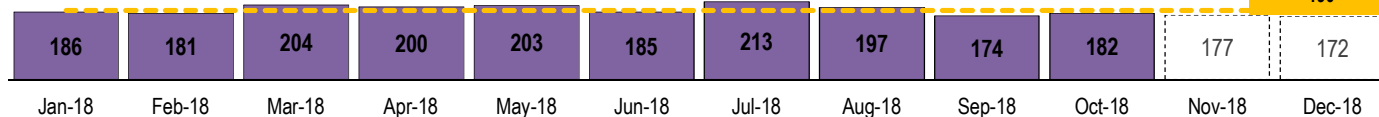

Projections based on actual monthly counts from October 2016 through current reporting month

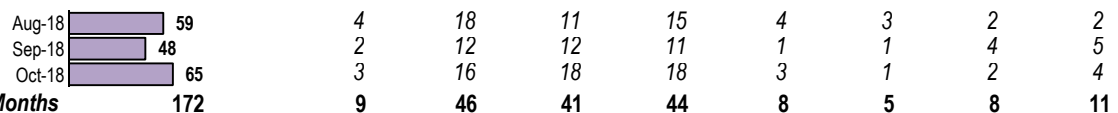

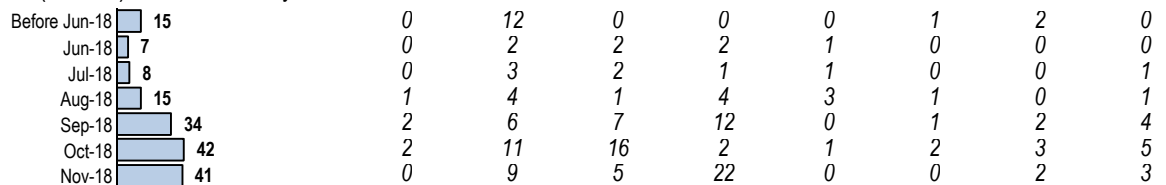
CHART 2. Chronic (Verified) in Past 3 Months

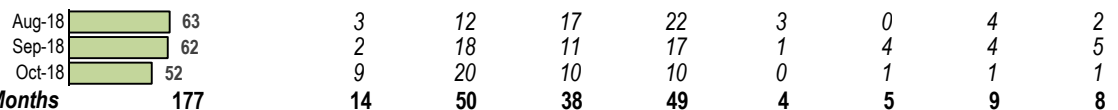

CHART 4. Chronic (Verified) and Housed, Past 3 Months



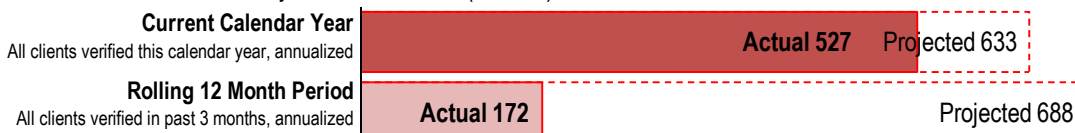

## **Overview of the Connecticut Statewide Monthly Chronic Housing Report (Individuals)**

This monthly report is based on data that is recorded on the By Name List (BNL) in HMIS. In order for progress to be recorded and appear in the report, client housing placements must be updated on the HMIS BNL by the 15<sup>th</sup> of the month. Below is a line by line and chart by chart description of the report.

**A – All Active Chronic (Verified)** – The count of all individuals on the BNL who are active and Chronic (Verified), statewide and by CAN

**B – Not Matched** – The count of all individuals on the BNL who are active, Chronic (Verified) and not matched, statewide and by CAN

**C – Matched** – The count of all individuals on the BNL who are active, Chronic (Verified) and matched, statewide and by CAN

**CHART 1. STATEWIDE Monthly Totals of Active Chronic (Verified) Individuals** – Total number of active Chronic (Verified) for each month so far, with projections through the end of the current calendar year based on data beginning with October 2016. *NOTE: The data in this chart is for all clients who are active and Chronic (Verified) in a given month, whereas CHART 2 and CHART 5 refer to the number of clients whose verification dates occurred within the time periods shown.*

**D – Verified in [month]** – The count of all individuals on the BNL who are Chronic (Verified) and whose verification date is in the month. These numbers will always match the numbers in line P.

**CHART 2. Chronic (Verified) in Past 3 Months** – Count of all individuals who are Chronic (Verified) and whose verification date is in each of the months shown. TOTAL VERIFIED in Past 3 Months is a sum of the three months shown, and this number will always match the “Actual” number in the Rolling 12 Month Period bar for CHART 5.

**E – Matched in [month]** – The count of all individuals on the BNL who are Chronic (Verified) and matched, whose matched date is in the month shown.

**F – Matched to PSH** – Count of all individuals on the BNL who are Chronic (Verified) and matched to this resource within the month

**G – Matched to RRH** – Count of all individuals on the BNL who are Chronic (Verified) and matched to this resource within the month

**H – Matched to HA/Subsidy Only** – Count of all individuals on the BNL who are Chronic (Verified) and matched to this resource within the month

**I – Matched to One Time Assistance** – Count of all individuals on the BNL who are Chronic (Verified) and matched to this resource within the month

**CHART 3. ACTIVE Chronic (Verified) and Matched, by Date Matched** – A count of all individuals on the BNL who are active, Chronic (Verified) and matched, broken out by month matched for each of the past 6 months. Clients matched more than 6 months ago are included in the “Before [month/year]” row at the top of CHART 3. This chart includes data for the current calendar month (typically the month after the report month listed at the top) because the data is pulled on the 15<sup>th</sup>, at which point some clients have already been matched to a resource.

**J – Housed in [month]** – The count individuals on the BNL who are Chronic (Verified) and housed, whose housed date is in the month shown. These numbers will always match the numbers in line Q.

**K – Housed with PSH** – Count of all individuals on the BNL who are Chronic (Verified) and housed with this resource within the month

**L – Housed with RRH** – Count of all individuals on the BNL who are Chronic (Verified) and housed with this resource within the month

**M – Housed with HA/Subsidy Only** – Count of all individuals on the BNL who are Chronic (Verified) and housed with this resource within the month

**N – Housed with One Time Assistance** – Count of all individuals on the BNL who are Chronic (Verified) and housed with this resource within the month

**O – Self-Resolved** – Count of all individuals on the BNL who are Chronic (Verified) and who self-resolved their housing crisis

**CHART 4. Chronic (Verified) and Housed, Past 3 Months** – Count of all individuals who are Chronic (Verified) and Housed, whose housed date is in each of the months shown. TOTAL HOUSED in Past 3 Months is a sum of the three months shown.

**P – Verified in [month]** – Data from line D, shown here for calculating net inflow in line R

**Q – Housed in [month]** – Data from line J, shown here for calculating net inflow in line R

**R – Past Month Chronic Inflow (net)** – Number verified in month (line P) minus the number housed in month (line Q). Low or negative numbers are good, and mean that more Chronic (Verified) individuals were housed than were verified in the past month.

**S – May Meet CH Criteria in Next 3 Mos.** – The count of all active individuals who are marked as “Not Chronic (Verified)” on the BNL who may meet the disability and homeless history criteria for CH in the next 3 months, based on dates entered by housing captains and others who maintain the BNL in each CAN.

**T – Potentially Chronic** – A count of the active clients on the BNL who are marked as potentially chronic. These clients may or may not currently meet the HUD criteria, but documentation is not on record to mark them as Chronic (Verified) for those who do

**CHART 5. STATEWIDE Projections of Chronic (Verified)** – Projections for the total number of individuals who may be verified as CH within the current calendar year or in a rolling 12 month period. Projections are updated each month.

**Current Calendar Year** – Uses actual total of clients who have been verified in the calendar year so far, divides that total by the number of months so far, and multiplies it by 12 to get an annualized projection for the current calendar year.

**Rolling 12 Month Period** – Uses actual total of clients who have been verified in the past 3 months (will always match statewide total in CHART 2), divides that total by 3, and multiplies it by 12 to get an annualized projection for the rolling 12 month period that includes the past 3 months and the next 9 months.
